| Explain: | Have engaged their Executive Directors and staff with FHN and educated them on our mission to build a Housing First Crisis Response System for the region. They are all now active members of FHN and have participated in both the January 2019 PIT and FHN's first Summer PIT Count in July of 2019. All of them utilize FHN Central Entry so that we can track data, refer and connect clients to appropriate resources and reduce duplication of resources. They have provided letters of support for FHN grant applications and participate in FHN Subcommittees. Culpeper Heat Shelter, the only ES in the region that accepts singles, is talking with their Board to see if they can become their own 501C3 and expand to be open year round. They are willing to participate in HMIS and plan to do so this winter season when they open back up in November 2019. Fauquier Family Shelter Services Executive Director has stated that they are open to using HMIS, but to date have not done so. MESA has not made any decision regarding HMIS. FHN will continue to work with all service providers to encourage them to utilize HMIS and move towards a Housing First model. |

(Jenny Biche taking over for Cathy Zielinski at RRRC in June 2018, Kyle Sensabaugh taking over for Melinda Fairhurst at People Inc. in March 2019, etc.) with the new staff getting acclimated to their new positions and mission of HUD, DHCD and Balance of State. This has been a learning year and FHN will be working hard on becoming more compliant and in line with the Housing First model. FHN will work with those service providers that still have Transitional Housing programs to see if they can move away towards that model of housing assistance and more towards the Housing First Approach. FHN will also work to get all service providers utilizing HMIS and to continue to utilize Central Entry. FHN also plans to offer training workshops on topics like Fair Housing, Case Management, etc. to ensure the most vulnerable receive the best support possible. FHN will also work on understanding their PIT Count results so that efforts and solutions can be put into place to improve those outcomes. With only two service providers, FHN has had limited success, but with a robust LPG membership, they hope to improve things significantly moving forward.
